Alert Fairfield - Gets an UPDATE!

Starting in January 2012, the Alert Fairfield emergency notification system is getting an update. As in the past, the Reverse Calling Emergency Notification system continues to be a tool that emergency responders can use to notify residents of Fairfield County of emergency situations. These situations could include a water boil alert, a missing person, an evacuation notice, or even a Shelter-in-Place notice.

Last year we notified the county residents that if they did not own a land-line phone, that this system required them to sign up online. We continue to request that residents sign up so that they can receive these priceless notifications.

Now, we are adding to the benefit of the system by adding Tornado warnings. These call

notifications would go out to

registered phone numbers with addresses located within the National Weather Services tornado warning box.

Once the warning was sent out by NWS, then the system would be automatically activated to notify by phone of the emergency and to take shelter.

In the past the only notifications of tornado warnings were the Outdoor warning signals (if you were outside) or television or radio announcements (if you were indoors or in your car). Plus, these notifications were for countywide, and not just the area really being affected. Now with this updated service, the warnings can come directly to your phone, allowing for immediate reaction and safety, and only to the homes in the warning area.

Please know that this service is only an optin service, so even if you have a landline, you must register that you would like to receive these notifications.

Planning and Operations @ EMA

The duty of preparing for an county emergency is a full time job of the EMA. As personnel, technology and skills change over time, so the response planning has to change to reflect the skills and abilities of the county. Current planning activities include:

1. The Annual updated Fairfield County 2011 Emergency Operating Plans (EOP) were mailed out to the jurisdictions with an effective date of 1 October 2011. We still have not received all the signed receipt's back from the agencies or organizations, as this is part of the plan process.

2. The Final FEMA Approved 2012 Fairfield County Debris Management Plan was sent out to our Debris Managers on 10 December 2011. Anyone that would like to have a copy can con-

tact Bill Gilliam at the Fairfield County EMA Office.

3. The Debris Management aspect of the emergency response is also being reviewed. We continue to work and research local vendors for Debris Removal contracts. These vendors will be on a preapproved list that can be used in the event of an incident, when mutual aid is exhausted.

Since October, we have had the help of Brian Hardwick and Mindy Armbrust taking over the daily organization of the Community Emergency Response Team (CERT) and the Medical Reserve Corps (MRC) respectively. Water Rescue Team

Fall 2011 presented a fairly slow season for the Dive/Water Rescue Team. We had a few

runs, that were eventually cancelled enroute by on scene personnel, some minor mechanical work on the truck, and one request for a pier inspection from the Ohio Fire Academy on East Main Street in Reynoldsburg. Diver Kurt Davis was called into service with his prior experience in the commercial diving field, and

Narrowbanding Radios

With the use of the FY2010 State Homeland Security Grant funds, the EMA was able to upgrade 94 mobiles and 127 handheld radios for county responders. These radios are currently being distributed to the local jurisdictional fire and law enforcement agencies around the county.

Since most of the jurisdictions had communication equipment that was not narrowband capable, these radio purchases were appreciated by everyone.

What to do... During Winter Storms and Extreme Cold

- Stay indoors during the storm.
- Walk carefully on snowy, icy, walkways.
- Avoid overexertion when shoveling snow. Overexertion can bring on a heart attack. If you must shovel snow, stretch before going outside.
- Keep dry. Change wet clothing frequently to prevent a loss of body heat.
- Watch for signs of frostbite. These include loss of feeling and white or pale appearance in extremities such as fingers, toes, ear lobes, and the tip of the nose. If symptoms are detected, get medical help immediately.
- Watch for signs of hypo-

- thermia. These include uncontrollable shivering, memory loss, disorientation, incoherence, slurred speech, drowsiness, and apparent exhaustion. If symptoms of hypothermia are detected, get the victim to a warm location, remove wet clothing, warm the center of the body first and give warm, nonalcoholic beverages if the victim is conscious. Get medical help as soon as possible.
- Drive only if it is absolutely necessary. If you must drive: travel in the day; don't travel alone; keep others informed of your schedule; stay on main roads and avoid back road shortcuts. Let someone

- know your destination, your route, and when you expect to arrive.
- If the pipes freeze, remove any insulation or layers of newspapers and wrap pipes in rags. Completely open all faucets and pour hot water over the pipes, starting where they were most exposed to the cold.
- Maintain ventilation when using kerosene heaters to avoid build-up of toxic fumes. Refuel kerosene heaters outside and keep them at least three feet from flammable objects.
- If you will be going away during cold weather, leave the heat on in your home, set to a temperature no lower than 55°F.
